MCIDL is a political action committee, which supports the legislative efforts of Interior Designers within our state to ensure the health safety and welfare of the public, which we serve. The coalition is necessary because professional organizations should not participate in the political process.

To be effective MCIDL must continue to be supported and funded. Your support allows our message to reach those whose support is necessary for the passage of this legislation.

It is the responsibility of each and every Interior Designer to support this effort. We have invited leaders from our professional organizations to attend our meetings in order to facilitate communication and benefit from their contributions to the discussions. 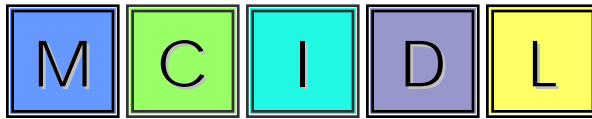
